


## Master NIS2's Human Factor Challenge

## The Challenge:

NIS2 mandates cybersecurity awareness training and human risk management, but most solutions focus on compliance theater rather than measurable risk reduction.



Transform mandatory training into a strategic security capability that satisfies regulators while actually reducing human-caused incidents.

NIS2's security framework includes multiple measures where human factors are critical - from awareness training to incident response capabilities.

#### **Training Scope**


NIS2 mandates extend beyond IT teams - all employees AND management must receive cybersecurity training.
